I have read, understand, and agree to abide by the Anime Conji Code of Conduct, Weapons & Props Policy, and other Anime Conji policies and procedures posted on the website at <http://www.anime-conji.org/>, and the terms and conditions of participation set out in this form, are effective and apply to me at all times when I am present on and around the Town & Country Resort during Anime Conji 2012. The duration of Anime Conji 2012 is defined to be from March 16, 2012 until March 18, 2012.
2. I acknowledge and agree that acceptance of any badge, membership or other form of admission issued by Anime Conji for entrance into Anime Conji 2012 constitutes acceptance of agreement to the following:
  - a. I am aware that audio-visual video or film recordings and photographs of Anime Conji 2012 and its participants and/or volunteers are created or recorded by approved industry and media representatives. Photos and footage are created in public areas, contests, panels, booths, and elsewhere at Anime Conji 2012. Such footage may be used in a highlights tape, marketing endeavor or for any other use;
  - b. I consent to such recording of me, my voice, and likeness, and any costumes or accessories I may be wearing or have with me while I am participating or volunteering in Anime Conji 2012;
  - c. I grant to Anime Conji 2012 the rights to reproduce, display, distribute, perform, create derivative works from, license,

sub-license and otherwise use any photos or footage, in whole or in part, of me, my likeness, my voice, and my costume or accessories in any media and in any manner including, but not limited to, the Internet, broadcast, satellite and other transmissions, including but not limited to in highlight tapes and other promotional and marketing materials for a commercial or non commercial purpose that concerns Anime Conji without any compensation to me whatsoever.

3. I do hereby fully and completely release and hold harmless Anime Conji from any and all harm, liability or damage from any personal injury or property losses that I may suffer arising out of or connected with, my participation in any and all Event.

I hereby acknowledge and agree freely and voluntarily assume any and all risks of participation in Anime Conji, and take full responsibility and waive any claims against Anime Conji of personal injury, death or damage to personal property associated with my participation in Anime Conji Events or presence on the premises where the Events are held, including but not limited to, engaging in activities such as: lifting or carrying objects, dance contests, matches of any kind, collapse or faulty construction of a stage or riser, product liability, any contests for money, prizes or entertainment purposes, consumption of Anime Conji-provided meals or food, or any and all other activities on and off the premises of the event.
5. In the Event of any injury or illness to me during my participation, I authorize the staff of Anime Conji 2012 to seek and obtain such emergency or medical services as may be deemed necessary at the time, but understand and agree that they shall not be obligated to do so.

I understand and acknowledge that if I break, deface, harm or damage any equipment or portion of the premises at which Anime Conji 2012 takes place, including, but not limited to, the Town & Country Resort, I shall be solely and personally responsible for paying any and all costs and consequential damages relating to the replacement or repair of the damaged item or facility.
7. This WAIVER & RELEASE contains the entire agreement between me and Anime Conji, and supersedes any prior written or oral agreements between us concerning Anime Conji. The provisions of this WAIVER & RELEASE may be not be waived, altered, amended or repealed, in whole or in part, except with written consent of all parties. I have read, understand and fully agree to the terms of this WAIVER & RELEASE. I understand and agree that by signing this WAIVER & RELEASE I have given up considerable future legal rights against Anime Conji, agents, officers, directors, employees, and volunteers. I have signed this agreement freely, under no duress or threat of duress. I further agree to indemnify and hold harmless Anime Conji from any and all Claims which are brought by or against me, and which are in any way connected with my participation in the Events.
